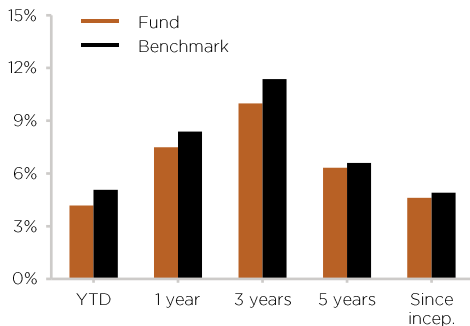
Risk Indicator Definition

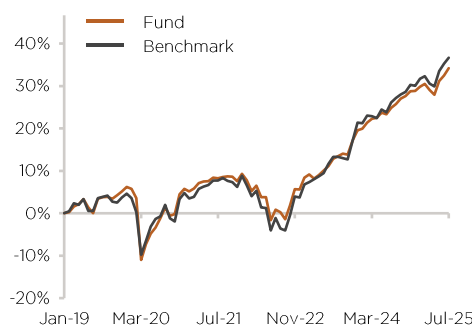
RISK INDICATOR

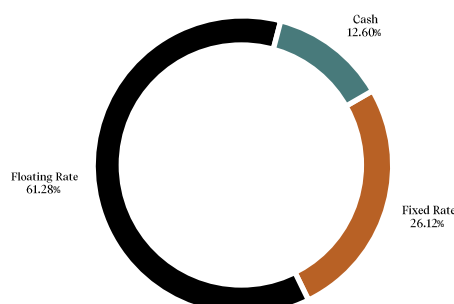

MARKET COMMENTARY

Market Dynamics:

European credit markets continued their bull run with the iTraxx Crossover 5-year spread index compressing by a further 14.5 basis points (bps) to end the month at 268 bps. It has been a quiet first 7 months of the year, apart from the short, sharp sell-off in the index that started during the last week of March and finished some two weeks later. Apart from that episode, it has been essentially one-way traffic for the index this year, with spreads compressing and the benchmark delivering decent returns to investors. For July, the iTraxx Total Return Index (inclusive of coupons and any defaults) produced 1.06% whilst its year-to-date number increased to 5.06%. Comparing this to European cash puts things into relative perspective, and offers some comfort to investors knowing how their money would have grown had they chosen to shun the asset class and avoid any risk-taking. The particular 3-month cash index that we use as a proxy for short-term risk-free, produced 0.17% on the month and has delivered a rather paltry 1.35% on a year-to-date basis.

On the default side of things, July was yet another default-free month. The Altice France default from June remains outstanding as far as the recovery auction is concerned, but with the underlying bonds trading in the 75% context, the losses to the current index MTM should be marginal. This outcome is all in the current pricing, so only a reduced recovery level in the auction will adversely affect performance.

The fund (A-class) gained 1.33% on an after-all-fees basis, generating a healthy excess return to the benchmark.

Looking to August, given that the Northern hemisphere is in summer holiday mode, we are expecting a quieter month as far as volatility is concerned, but remain poised to act on any pullback of spreads. The fund remains short of benchmark beta whilst generating excess spread on a pre-fees basis.



Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

High Water Mark: The highest level of performance achieved over a specified period.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Performance fee incl. in TER (%) PF (%): The Performance Fee is a payment made to the Fund Manager for generating outperformance and is generally calculated as percentage of outperformance, often both realized and unrealized.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

Specific Risk

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
